

About This Document This document sets forth the Culture Assault Records Online Privacy Policy (the "Privacy Policy") for this Web site, Culture Assault Records - www.culture-assault.net (the "Site"). If you have objections to the Privacy Policy, you should not access or use this Site. This Privacy Policy does not govern privacy practices associated with offline activities or other Culture Assault Records web sites.

Changes In Privacy Policy All "personal information" ("personal information" is defined as any information that identifies or can be used to identify, contact, or locate the person to whom such information pertains) that we collect and maintain will be subject to the version of the Privacy Policy in effect at the time of such collection. Culture Assault Records reserves the right to change the Privacy Policy from time to time at its sole discretion. If as the result of such changes, you want to alter the ways in which Culture Assault Records is allowed to use your personal information, you can do so by following the procedure described in the section entitled "Updating your Personal Information and Privacy Preferences." this Site, you can engage in many activities without providing any personal information. In connection with other activities, such as utilizing online software applications, Culture Assault Records may ask you to provide certain information about yourself by filling out and submitting an online form. It is completely optional for you to engage in these activities. If you elect to engage in these activities, however, Culture Assault Records may ask that you provide us personal information, such as your first and last name, mailing address (including ZIP code), e-mail address, employer, job title and department, telephone and facsimile numbers, and other personal information. When ordering products or services on the Site, you may be asked to provide a credit card number. Depending upon the activity, some of the information that we ask you to provide is identified as mandatory and some as voluntary. If you do not provide the mandatory data with respect to a particular activity, you will not be able to engage in that activity.

When you use the Site, Culture Assault Records or third parties authorized by Culture Assault Records may also collect certain technical and routing information about your computer to facilitate your use of the Site and its services. For example, we may log environmental variables, such as browser type, operating system, CPU speed, and the Internet Protocol (IP) address of your computer. We use these environmental variables to facilitate and track your use of the Site and its services. Culture Assault Records also uses such environmental variables to measure traffic patterns on the Site. Without expressly informing you in each particular circumstance, we do not match such information with any of your personal information.

When you submit personal information to Culture Assault Records through this Site, you understand and agree that this information may be transferred across national boundaries and may be stored and processed in any of the countries in which Culture Assault Records and its affiliates and subsidiaries maintain offices, including without limitation, the United States. You also acknowledge that in certain countries or with respect to certain activities, the collection, transfer, storage, and processing of your information may be undertaken by trusted vendors of Culture Assault Records. Such vendors are bound by contract to not use your personal information for their own purposes or provide it to any third parties. One instance where this could occur is in conjunction with framed pages in which the URL for the pages is not visible,

and the pages are being hosted by a vendor of Culture Assault Records.

Culture Assault Records has established relationships with various service providers whose services are available to you from this Site or from Web sites that are linked to this Site. How Your Personal Information Is Used Culture Assault Records collects your information in order to record and support your participation in the activities you select. If you subscribe to a service or register a product, for example, the information is used to register your rights, if any, to technical support or other benefits that may be made available to registered users. As another example, if you enter a contest, information is collected to qualify the entry and to contact you regarding the contest or prize awards. Culture Assault Records may collect information about the use of the Site, such as the types of services used and how many users we receive daily. Your Choices With Respect To Personal Information Culture Assault Records recognizes and appreciates the importance of responsible use of information collected on this Site. Without your consent, Culture Assault Records will not communicate any information to you regarding products, services, and special offers available from Culture Assault Records, although we may find it necessary to communicate with you regarding your use of the services on this Site. Except in the particular circumstances described in this Privacy Policy, Culture Assault Records will also not provide your name to other companies or organizations without your consent. There are other instances in which Culture Assault Records may divulge your personal information.

Culture Assault Records may provide your personal information, if necessary in Culture Assault Records's good faith judgment, to comply with laws or regulations of a governmental or regulatory body or in response to a valid subpoena, warrant, or order or to protect the rights of Culture Assault Records or others.

Protection Of Your Personal Information The personal information that you provide in connection with registering yourself as a user of Culture Assault Records products or services or registering an Culture Assault Records product is classified as Registration Information. Registration Information is protected in several ways. Access by you to your Registration Information is available through a password and unique customer ID selected by you. This password is encrypted. We recommend that you do not divulge your password to anyone. In addition, your Registration Information resides on a secure server that only selected Culture Assault Records personnel and contractors have access to via password. Culture Assault Records encrypts your personal information and thereby strives to prevent unauthorized parties from viewing such information when it is transmitted to Culture Assault Records.

Personal information that you provide that does not constitute Registration Information also resides on a secure server and is only accessible to selected Culture Assault Records personnel and contractors via password. Since this information is not accessible by you, you will not be asked to select a password in order to view or modify such information.

Please note that any information you post to a public bulletin board or chat room is available to all persons accessing that location. Your e-mail address will not automatically be posted on the Forums unless you modify the default setting to permit that. Your e-mail address would then be available to all persons accessing the Forums. In addition, you should be aware that the Forums offer a service in which subscribers are e-mailed a copy of all messages posted to the Forums on a particular topic. Use Of Cookies When you visit this Site, you can browse the Site and access important information without revealing your identity. In order to improve our Site, we use "cookies" to track your visit. A cookie is small amount of data that is transferred to your browser by a Web server and can only be read by the server that gave it to you. It functions as your identification card and enables Culture Assault Records to record your passwords, purchases, and preferences. It cannot be executed as code or deliver viruses.

Most browsers are initially set to accept cookies. You can set your browser to notify you when you receive a cookie, giving you the chance to decide whether or not to accept it. (For some Web pages that require an authorization, cookies are not optional. Users choosing not to accept cookies will probably not be able to access those pages.)
